The National Spatial Strategy confirms Sligo's status as the premier economic gateway of the northwest region. The Sligo Local Authorities are working with the Department of the Environment, Heritage and Local Government, the Department of Transport and the National Roads Authority to develop a transport infrastructure to underpin our continuing growth and development. The newly opened Sligo Inner Relief Road has resulted in major benefits to motorists and will also facilitate the pedestrianisation of city centre streets. Proposals for a Western Distributor Road and a Western bypass are identified in the Sligo & Environs Development Plan, and the delivery of these projects will further enhance our position as a dynamic and progressive urban centre.

The Eastern Garvoge Bridge will provide an eastern distributor road which will further reduce traffic congestion in the city centre. The new bridge will join the communities north and south of the Garvoge River, linking the large residential and commercial centres south of the river with Sligo Regional Hospital, Sligo Institute of Technology and the growing suburb of Ballinlode.

Sligo Borough Council requires the services of competent Consulting Engineers, experienced in major civil/structural engineering and particularly bridge works.

Work will include:-

1. Consideration of optional river crossing locations and recommendation.
2. Appointing and managing specialists sub consultants involved in 1 above, and in the production of an EIS.
3. Preparation of optional bridge designs at chosen crossing point.
4. Development of preferred structure.
5. Production of EIS etc.
