**Press Notice** S.I. No. 566 of 2008 **EUROPEAN COMMUNITIES** (PREPACKED PRODUCTS) **REGULATIONS 2008** 

The Tánaiste and Minister for Enterprise, Trade and Employment, Mary Coughlan, T.D., in exercise of the powers conferred on her by section 3 of the European Communities Act 1972 (No. 27 of 1972) has made Regulations entitled as above.

These Regulations give effect to Directive 2007/45/EC of the European Parliament and of the Council of 5 September 2007 laying down rules on nominal quantities for prepacked products, repealing Council Directives 75/106/EEC and 80/232/EEC and amending Council Directive 76/211/EEC. The effect of the regulations is to deregulate from 11th April 2009 almost all of the rules on nominal quantities for prepacked products. These rules are sometimes called range of sizes legislation and their purpose is to restrict the sizes in which certain products can be placed on the market. From 11th April 2009 the only mandated sizes for products will be for those wines and spirits specified in the Annex to the Directive. As a consequence of this Directive Orders made under the Merchandise Marks Act, 1970. which specify that certain products can only be placed on the market in certain nominal quantities will be revoked. The regulations come into operation on 11th April 2009


