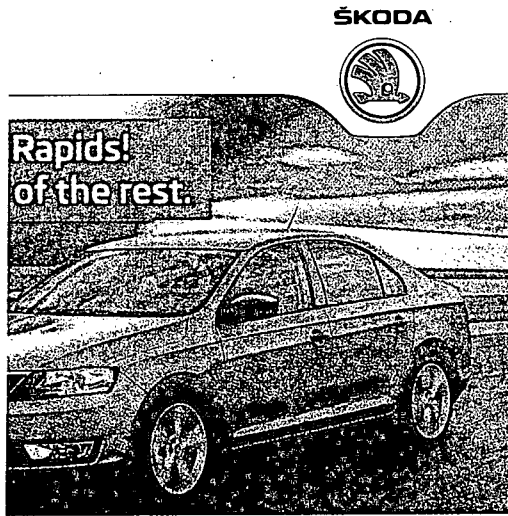

**PLANNING APPLICATIONS**

**DUBLIN CITY COUNCIL** — The Trustees of Belvedere College S.J., apply for planning permission for upgrading and conservation works to a 3-storey over basement protected structure Belvedere House, Denmark Street Great, Dublin 1 to which a section 5 exemption (Application no. 0817/08) was granted. Externally the proposed works include re-pointing, repair to stone rusticated ashlar, replacement of paving in area at rear landing, replacement of railings to rear. Internally, the works consist of general repairs to damage due to damp and timber decay, in isolated areas, structural strengthening of floors, adaptation of existing offices to staff common area, on the second floor and upgrading of on-suite accommodation, on the third floor. The tower is within an existing chain-link fence compound using an existing access route at Coon (Td) and Knockoura (Td), Ailhes, Castletownbere, County Cork.
