TRANSFER OF A WASTE LICENCE

Decision of the Agency, under Section 47(5) of the Waste Management Acts, 1996 to 2013

Waste Licence Register No: **W0054-02**

The Agency, in exercise of the powers conferred on it by the Waste Management Acts, 1996 to 2013, for the reasons hereinafter set out, hereby transfers waste licence register number W0054-02 from Eco-Safe Systems Limited, Unit 1A, Allied Industrial Estate, Kylemore Road, Ballyfermot, Dublin 10 to SRCL Limited, Unit 430, Beech Road, Western Industrial Estate, Naas Road, Dublin 12, CRO No: 258299. Waste Licence Register No W0054-02 licenses the carrying on of the waste activities set out below at Unit 1 A, Allied Industrial Estate, Kylemore Road, Ballyfermot, Dublin 10 subject to twelve Conditions, as set out in the waste licence.

| Class 7. | Physico-chemical treatment not referred to elsewhere in this Schedule (including evaporation, drying and calcination) which results in final compounds or mixtures which are disposed of by means of any activity referred to in paragraphs 1. to 10. Of this Schedule. Class 7 is the principal activity and refers to the sterilisation of healthcare risk waste in a Rotoclave and a Static Autoclave at the facility. |
| Class 12. | Repackaging prior to submission to any activity referred to in a preceding paragraph of this Schedule. This activity relates to the baling and repackaging of various waste types prior to disposal off-site. |
| Class 13. | Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned was produced. This activity relates to the storage of hazardous waste at the facility prior to disposal on-site or off-site. |

| Class 13. | Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned was produced. This activity is limited to the storage of waste at the facility prior to on-site or off-site recovery. |


In accordance with Section 47(6) of the Acts, SRCL Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, they may arise.

REASONS FOR THE DECISION

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that SRCL Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that SRCL Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the programme officer's report.
