# 1. EXECUTIVE SUMMARY

This is the second report on Green Public Procurement activity by Government Departments, relating to reference year 2021.<sup>1</sup> The report provides an overview of the obligations to monitor and report on GPP, describes the scope of reporting and presents a summary of the findings, conclusions and recommendations.



The Climate Action Plan 2019 assigned lead responsibility to the Environmental Protection Agency (EPA) for measuring and reporting Green Public Procurement (GPP) implementation by Government Departments on an annual basis, starting with reference year 2020.

All 18 Government Departments provided returns for 2021 reference year, which requested data for GPP implementation at contract level, where the contract value was greater than €25,000 and the contract was signed in calendar year 2021.

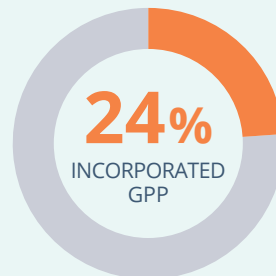
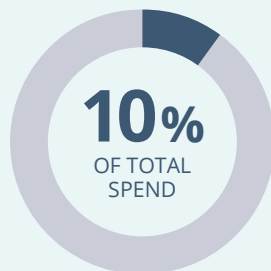
## Government Departments reported:

A total spend of

**€54.954 million**

on contracts over €25,000, which were signed in 2021 and included green criteria.

This represents an average of **10%** of the total spend reported on contracts over €25,000.<sup>2</sup>



24% of the total number of procurement contracts over €25,000 which were signed in 2021 were **REPORTED TO HAVE INCORPORATED GPP**<sup>3</sup>

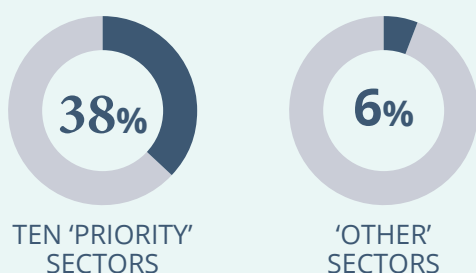

## Government Departments reported:

In relation to ten 'priority' sectors for which national GPP criteria sets are published, green criteria were incorporated in 38% of the spend reported, representing 30% of the number of contracts. In relation to 'other' sectors reported, green criteria were incorporated in 6% of the spend, representing 22% of the number of contracts.<sup>4</sup>

Government Departments reported on GPP in their 2021 Annual Reports<sup>5</sup>

The findings point to a low level of GPP implementation across Government Departments in 2021; lower than the levels reported for 2020 reference year in relation to the percentage of contract spend (17% in 2020, 10% in 2021) and percentage of contracts (26% in 2020, 24% in 2021) which incorporated green criteria. Similar to 2020, there was significant variation across Government Departments in the reported spend on contracts that included green criteria (ranging from 0% to 100%). This low level of implementation is a missed opportunity for Government Departments to purchase more resource efficient and less polluting goods, services and works within the marketplace. Government Departments need to place a greater focus on GPP implementation within their procurement processes, particularly for the ten priority sectors for which there is published national guidance and criteria sets.

The dataset is incomplete, with information gaps referenced in the returns as well as the potential for missing information given the lack of GPP tracking processes in some Departments (only 50% of Government Departments reported having a tracking system in place). There is significant scope for improvement in relation to incorporating GPP into procurement policy and plans (including the Corporate Procurement Plan) and to provide GPP training to relevant staff.

The increase in the number of Government Departments reporting on GPP in their Annual Reports is a positive indication of the awareness of the requirement of Department of Public Expenditure and Reform's Circular 20/2019.<sup>6</sup>

The EPA will continue to work with Government Departments, the Office of Government Procurement and the Department of the Environment, Climate and Communications to support GPP implementation.

**At a minimum, every Government Department should focus on the following:**



Assigning senior level resources with a responsibility to ensure GPP is incorporated into procurement processes



Updating procurement procedures and policies (including the Corporate Procurement Plan) to include GPP



Ensuring that the relevant staff receive GPP training and are aware of the available guidance<sup>7</sup>



Ensuring that there are tracking systems to monitor and report on GPP implementation and in particular details on the type of green criteria applied



Ensuring that GPP data is included in published Annual Reports

## 2. INTRODUCTION

### GREEN PUBLIC PROCUREMENT (GPP) IS DEFINED AS:

“A process whereby public authorities seek to procure goods, services and works with a reduced environmental impact throughout their life cycle when compared to goods, services and works with the same primary function that would otherwise be procured.”<sup>8</sup>

The public sector has a vital role to play in leading Ireland’s transition to a sustainable and carbon-neutral economy and society. The purchasing power of Ireland’s government sector (€21.9 billion annually<sup>9</sup>) has significant potential to reduce emissions and protect our environment while saving money over the full lifecycle of goods and services. Government commitment to green purchasing sends a powerful signal to the market that the Government requires goods, services and works that make the most positive contribution to our environment and can save money over their full lifecycle. It promotes innovation in the marketplace for goods and services with a reduced environmental impact.

A wide range of international, EU and national policy instruments and plans reference Sustainable or Green Public Procurement as an important tool in effecting environmental change, including UN Sustainable Development Goal 12.7, the European Green Deal, Ireland’s Climate Action Plans and Whole of Government Circular Economy Strategy.

The Climate Action Plan 2019 assigned lead responsibility to the Environmental Protection Agency (EPA) for an action that Government

Departments would measure and report on GPP on an annual basis, starting with calendar year 2020. The EPA’s first publication on GPP implementation by Government Departments for reference year 2020 reported a low level of implementation and discussed the requirement for further engagement with all stakeholders to support the efficient and effective collection of data annually. The EPA carried out the following activities in 2022 to support implementation of GPP across Government Departments:

- Conducted an online survey to gather feedback on the reporting template and data collation process.
- Hosted an online workshop focussed on identifying training needs, describing the data collection process and the reporting template.
- Offered six GPP training courses for procurers & specifiers in the public sector. Seventeen staff from seven Government Departments attended the training in 2022.
- Engaged with the Office of Government Procurement (OGP), including collaboration on the development of the online GPPCriteriaSearch tool<sup>10</sup> and through participation in the national Strategic Procurement Advisory Group.

This is the second report in a series on GPP activity by Government Departments, collating and analysing data for reference year 2021. The report provides an overview of the obligations to monitor and report on GPP, describes the scope of reporting and presents a summary of the findings, conclusions and recommendations. Its publication fulfils Action PS/23/12/B of the Climate Action Plan 2023.

## 3.

## OBLIGATIONS TO MONITOR &amp; REPORT ON GPP

The Department of Public Expenditure and Reform (D/PER) Circular 20/2019 states that:

- i. each Department should state in their next Corporate Procurement Plan where it intends to use green criteria in upcoming procurement processes.<sup>11</sup>
- ii. starting with the 2020 Annual Report each Department must report annually on its green public procurement. The Annual Report must include information relating to the value of contracts agreed upon that included green criteria.

This monitoring & reporting requirement only applies to

- i. central Government Departments and
- ii. contracts valued at €25,000 and above.

The Climate Action Plan 2019 (Action 148) assigned lead responsibility to the EPA for an action that Government Departments would measure and report on GPP on an annual basis, starting with calendar year 2020.

The monitoring and reporting by Government Departments is to support the commitment under the Programme for Government: Our Shared Future which states that “we will mandate the inclusion of green criteria in all procurements using public funds, to be completed within 36 months”.

The Climate Action Plan 2023 states that “annual monitoring and reporting on GPP by Government Departments will continue” and that “GPP reporting structures and guidelines for public bodies will be developed in 2023/2024”.

## 4. SCOPE OF REPORTING

While there is no standardised reporting system in place at EU level for monitoring GPP implementation, best practice examples from exemplar GPP regions indicate that monitoring systems should include a record of the number and value of tenders and/or awarded contracts which included GPP criteria.

The EPA, in co-operation with the Department of the Environment, Climate and Communications and the Office of Government Procurement, developed a reporting template for 2021 reference year reporting (Appendix 1). This sought information under the ten 'priority' sectors listed in the EPA's Green Public Procurement – Guidance for the Public Sector, published in September 2021 (Table 1).<sup>12</sup>

'Other' sectors that represent government departmental spend (as demonstrated by the 2020 returns) were also included in the 2021 template (Table 2).

The reporting template was sent to all Government Departments in July 2022 with a request that the completed form be returned to the EPA by 30 September 2022.

The reporting template requested information about the number and value of contracts signed in 'priority' and 'other' sectors valued above €25,000 which included criteria designed to ensure that the product or service procured would have a reduced impact on the environment.

The EPA requested that information be reported at contract level, where the contract value was greater than €25,000 and the contract was signed in calendar year 2021. To avoid duplication of reporting across years, the EPA asked for information at signed contract stage only. It

should be noted that 2021 reporting to the EPA was for Government Department contracts only and not for agencies affiliated to those Government Departments.

The reporting template also requested some qualitative information, including whether the Department has a GPP policy or strategy, whether staff received training on GPP and whether the Department has a system for tracking GPP.

DPER's Circular 20/2019 requires Government Departments to report annually on their GPP activities in their published Annual Reports. Appendix 4 gives the status of GPP reporting in departmental Annual Reports for 2021 at the time of publication.

## 5. GUIDELINES FOR DETERMINING A GREEN PROCUREMENT

To determine if a contract was to be included in reporting, the following guidelines, which were developed in consultation with the OGP, were provided to the Departments:











- i. A contract can be included as a green procurement if criteria are included which are designed to ensure that the product or service procured will have a reduced impact on the environment.
- ii. Green criteria can be included in the procurement process:
  - When defining the subject matter of the contract
  - In the use of legislative/statutory requirements which have an environmental dimension
  - In the requirements for technical/professional ability of the tenderer
  - In the technical specifications
  - In the selection criteria
  - In the award criteria
  - In the application of Life Cycle Costing
  - In contract performance or management clauses

The guidance to Government Departments noted that examples of green criteria for each of the ten priority sectors could be found in the EPA's Green Procurement Guidance or on the EU GPP website. However, these were noted as non-exhaustive lists and additional criteria could be considered green as long as they were included in the tender process and they aimed to ensure the subject of the tender would have a reduced environmental impact.

## 6. FINDINGS

All 18 Government Departments replied to the data request. The quantitative data returned are summarised in Table 3 ('priority' sectors for which there are national criteria sets) and Table 4 ('other' sectors). The data provided by each Department is presented in Appendix 3.

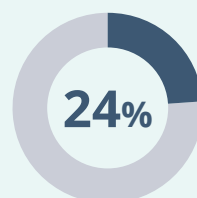
### Key findings from the quantitative data:

- In 2021, there was a total spend of €54.954 million on contracts over €25,000 which were signed in 2021 and that included green criteria. This represents an average of 10% of the total spend reported on contracts over €25,000.<sup>13</sup>
- Of the total number of procurement contracts over €25,000 which were signed in 2021, 24% were reported to have incorporated GPP.<sup>14</sup>
- There was significant variation between Government Departments in the reported percentage spend on contracts that included green criteria (ranging from 0% to 100%). Some of this variation can relate to the type and level of procurement undertaken by government departments in the year of reporting.
- In relation to 'priority' sectors for which national GPP criteria sets are published (Table 3), green criteria were incorporated in 38% of the spend reported, representing 30% of the number of contracts. In relation to 'other' sectors (Table 4) green criteria were incorporated in 6% of the spend reported, representing 21% of the number of contracts.<sup>15</sup>
- There are missed opportunities for incorporating green criteria in contracts in 'priority' sectors for which national criteria are available (e.g. ICT Products and Services, with 107 contracts reported and 10 incorporating green criteria).
- There were four 'priority' sectors for which no contracts were reported: Food & Catering Services; Heating Equipment, Indoor & Outdoor Lighting, Textiles Products & Services.
- There were 'other' sectors (i.e. those for which no national GPP criteria are published) where green criteria were incorporated; for example laboratory equipment (42% of total spend of contracts incorporated green criteria) and facilities management (23% of total spend incorporated green criteria).
- One Department reported having no contracts over €25,000 in 2021.<sup>16</sup>

The findings point to a low level of GPP implementation across Government Departments in 2021, with opportunities to increase implementation, particularly for "priority" sectors for which there are published national criteria.

The GPP dataset is incomplete and under-represents the true spend and number of contracts that included green criteria. For example, one Department reported four contracts for ICT Products and Services which included green criteria; but no information on the value of the contracts was reported. Another Department reported 33 contracts (with 4 incorporating GPP), but no information on the value of the contracts. Another potential gap in the dataset is missing information given the lack of GPP tracking processes in some Departments.

The increase in the number of Government Departments reporting on GPP (16 in 2021 Annual Reports, 10 in 2020 Annual Reports) is a positive indication of awareness of the requirement to report on GPP in Annual Reports.

The reporting template included some questions linked to GPP implementation:

From these qualitative findings, there is significant scope for improvement in relation to having GPP tracking systems in place to support monitoring and reporting, to incorporate GPP into procurement policy and plans and to provide training to relevant staff.

## CONCLUSION &amp; RECOMMENDATIONS

Similar to 2020, there was significant variation across Government Departments in the reported spend on contracts that included green criteria (ranging from 0% to 100%). This low level of implementation is a missed opportunity for Government Departments to purchase more resource efficient and less polluting goods, services and works within the marketplace. Government Departments need to place a greater focus on GPP implementation within their procurement processes, particularly for the ten priority sectors where there is published national guidance and criteria sets.

There are challenges in terms of the collation and reporting of data which need to be overcome

to form a complete picture of GPP activities in future reporting years. The dataset is incomplete, with information gaps referenced in the returns as well as the potential for missing information given the lack of GPP tracking systems in some Departments. There is significant scope for improvement in relation to incorporating GPP into procurement policy and plans (including the Corporate Procurement Plan) and to provide GPP training to relevant staff.

Continued engagement with Government Departments is required to improve data collation and ensure that the process is efficient, consistent, and the data returned are representative of GPP implementation. The method for monitoring GPP results may need to be adapted to take cognisance of developments which are not captured at procurement stage, such as progressive actions for reducing environmental impacts.

#### AT A MINIMUM, EVERY GOVERNMENT DEPARTMENT SHOULD PLACE A FOCUS ON THE FOLLOWING:



Assigning senior level resources with a responsibility to ensure GPP is incorporated into procurement processes



Updating procurement procedures and policies (including the Corporate Procurement Plan) to include GPP



Ensuring that the relevant staff receive GPP training and are aware of the available guidance<sup>17</sup>



Ensuring that there are tracking systems to monitor and report on GPP implementation and in particular details on the type of green criteria applied



Ensuring that GPP data is included in published Annual Reports

The EPA will continue to work with Government Departments, the Office of Government Procurement and the Department of the Environment, Climate and Communications to support GPP implementation. The Climate Action Plan 2023 states that GPP reporting structures and guidelines for public bodies will be developed in 2023/2024 and the EPA will share learnings from the monitoring and reporting by Government Departments to inform this work. The EPA's GPP guidance and criteria sets will be kept up to date

with policy and legislation, as well as looking at the potential for new national criteria sets, aligning to EU GPP criteria or national needs.

A national GPP Strategy and Action Plan is currently under development led by the Department of the Environment, Climate and Communications. This national strategy will be welcome, to set targets for GPP implementation, and roles and responsibilities regarding GPP training, guidance, monitoring and reporting.
