He previously served as Minister of State at the Department of Housing with responsibility for Planning and Local Government. Before entering political life, Alan built a successful career in the multinational life sciences sector, specialising in biologics and pharmaceutical drug manufacturing and medical devices.

He is a graduate of Maynooth University with a double honours Bachelor of Science degree in Applied Mathematics and Biology, holds a Master of Science degree in Pharmaceutical Science from the Royal College of Surgeons in Ireland, and earned a Postgraduate Diploma in Education from the University of Galway.

In addition to his political and professional achievements, Alan had a distinguished sporting career, representing Mayo as a senior footballer for 15 years. He captained the team and earned two GAA All-Star awards.

Laura Burke, Director General of the Environmental Protection Agency (EPA).

Laura was appointed in 2011 and served as a Director within the EPA since 2004.

As Director General she has the responsibility to lead and strategically manage the EPA. Laura was the Chair of the European Environment Agency (EEA) Management Board from 2017 to 2023. Laura is a member of the Climate Change Advisory Council (CCAC) and a member of the High Level Implementation Committee of 'Food Vision 2030', the Irish Agri-Food Sector Strategy. Prior to joining the EPA, she worked in the private sector. Laura is a graduate chemical engineer of University College Dublin (UCD), holds an MSc from Trinity College, Dublin, is a Fellow and is President of Engineers Ireland and is a Chartered Director. In 2025 Laura was appointed an Adjunct Full Professor in University College Dublin.

Dr Florian Flachenecker, Taskforce Leader on the Circular Economy Act, DG ENV

Florian Flachenecker is Taskforce Leader for the Circular Economy Act in the Directorate-General for Environment at the European Commission. Florian is also an Honorary Lecturer in environmental economics at University College London.

Previously, he worked in the Recovery and Resilience Taskforce that directly reports to Commission President Ursula VON DER LEYEN on supporting green investments under the €723 billion Recovery and Resilience Facility.
