

# **Site Visit Report**

Under the *European Union (Drinking Water) Regulations 2023*, the Environmental Protection Agency (EPA) is the supervisory authority in relation to Uisce Éireann and its role in the provision of public drinking water supplies. This audit was carried out to assess the performance of Uisce Éireann in providing clean and wholesome water to the public water supply named below.

The audit process is a sample of the performance of a water treatment plant and public water supply on a given date.

### > Summary of Key Findings

- 1. Kilineer Water Treatment Plant (WTP) was operating satisfactorily on the day of the audit.
- 2. The protozoal log treatment requirement for Kilineer WTP has not been assessed to date.

### > Introduction

Kilineer Public Water Supply (PWS) serves a population of 27 (EDEN figure) and is supplied by Kilineer WTP. The treatment plant produces approximately 5 m3/day and sources its water from a single borehole located at the treatment plant. Treatment consists of cartridge filtration and UV disinfection.

The audit was undertaken to assess Uisce Éireann's performance in producing clean and wholesome water.

#### Comment

1. The electrical cable powering the borehole pump that runs between the pumphouse and borehole was visible and accessible leaving it vulnerable to outside interference.
