We confirm the following in italics in relation to your query on the planting on the Northern boundary:

Significant impacts on vegetation are not likely beyond 50m. This is further reduced by the presence of earth banks or vegetative screening onsite, disrupting the emission pathway and shielding receptors. The existing hedge to the north of the site is increasing in width and density and will be over 4m in width.
