


## Registering an abstraction in Water Abstractions Module

Note: the maximum daily volume for your abstraction should be measured or estimated before proceeding. Abstractions that have a maximum daily volume of less than 25 m<sup>3</sup> per day (25,000 litres) cannot be registered.
