The Environmental Protection Agency (EPA) is the competent authority for the deliberate release of Genetically Modified Organisms (GMOs) in Ireland in accordance with EU Directive 2001/18/EC (on the deliberate release into the environment of genetically modified organisms). This Directive concerns both the placing on the market of GMOs and the deliberate release of GMOs into the environment for non-commercial purposes i.e. for the performance of field trials for research and development purposes. Member States are obliged to ensure that all appropriate measures are taken to avoid adverse effects on human health and the environment which might arise from the deliberate release of GMOs into the environment.

During 2017, several varieties of unauthorised GM petunia were found on the ornamental plants market in Ireland. While GM petunia poses negligible risk to human or animal health or the environment, unauthorised GM varieties had to be withdrawn from the market and destroyed as they were not authorised for sale or distribution within the EU.

In advance of the forthcoming marketing season the Agency wishes to raise awareness and reduce the risk of unauthorised GM ornamental plants entering the Irish market. The Agency requests that you advise importers of ornamental plants / seeds to be vigilant and ensure that plant varieties being imported are not genetically modified and to seek confirmation from the supplier of the plant's non-GM status in writing.

l attach a full list of petunia varieties identified as genetically modified throughout Europe during the 2017 growing season.

The Agency will follow up and advise you of any further developments in this area, as appropriate.
